



### Ride for a reason 2019 | Dollar Match Day | Ochre Jersey Competition | TERMS AND CONDITIONS

1. Instructions to enter the Ride for a reason 2019 (RFAR19) King of the Mountain Ergo competition (the Draw) form part of these conditions.
